

## RESOLUTION 2022-2 DESIGNATION OF FACILITIES

## IN THE MATTER OF COMPLIANCE WITH OHIO STATUTORY REQUIREMENTS:

WHEREAS, the current solid waste management plan of the CFLP Solid Waste District, approved by the Director of the Ohio Environmental Protection Agency on January 17, 2019, authorizes the Board of Directors of the District to designate one or more solid waste facilities for receipt of solid waste generated within or transported into the District for disposal or transfer, and

WHEREAS, pursuant to Ohio Revised Code §343.014(B), the board of directors of a district that wishes to designate solid waste disposal or transfer facilities, where wastes generated within or transported into the district shall be taken for disposal or transfer, shall initiate the proceedings to do so by adopting a resolution expressing the intent of the board to so designate any such facilities and activities for the receipt of wastes generated within and transported into the district, accomplished with Resolution 2021-1 adopted by the Board of Directors on October 22, 2021, and

WHEREAS, the board of directors continued the designation process by holding a public hearing on February 25, 2022, adopting Resolution 2022-1 to declare their intent to designate on June 24, 2022, held a 30-day public comment period and considered all public comments, and

WHEREAS, the District has chosen to continue the designation process by adopting a resolution of final designation containing the list of designated facilities and facilities for which waivers have been granted,

NOW, THEREFORE,

## BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE COSHOCTON-FAIRFIELD-LICKING-PERRY SOLID WASTE DISTRICT

The Board of Directors of the CFLP Solid Waste District designates and grants waivers to the solid waste facilities listed herein to which solid waste generated within or transported into this District shall be taken for disposal or transfer. This designation becomes effective 60 days after the adoption of this resolution.
